CFMS Sponsorship Framework

Last year the CFMS developed a new sponsorship framework. In this last fiscal year, I and our general manager have grown meeting sponsorship by nearly 50%.

In partnership with out IT Officers, on-line payments were launched this summer for CFMS individual membership and exchanges.

In addition to regular meetings, enhanced online presence, this year I've begun to directly work the provincial & territorial medical association (PTMA) wealth leads, to further explore partnership opportunities and tools for our members.
