I. ACTIVITIES OF DIRECTOR GLOBAL HEALTH

The CFMS Director of Global Health is responsible for overseeing global health projects that develop at a national level via National Officers, and supporting projects at the local level via Global Health Liaisons. The Director of Global Health is a liaison between these parties, as well as external persons and organizations such as the International Federation of Medical Students' Association (IFMSA).

As per the CFMS bylaws, the Director of Global Health shall, in addition to the person's other duties within the Board, direct the delivery of the Global Health Program (GHP) and support the activities of the constituency on matters pertaining to global health, international development, and public health.

I am pleased to discuss here the activities conducted within the Director of Global Health Portfolio for the term of 2019-2020.

1. Overseeing Global Health National Officer Portfolios

The national officers have been very independent in carrying out the great work being done in their respective portfolios. Please see their National Officer Reports (uploaded to the CFMS website) for details of the work they have carried out throughout the term. Over the summer, Fatemeh and I worked together with the National Officers to interview and select successors for their roles. National Officers were given the final say in who they felt would be best for the role, as they are most familiar with the skills and abilities needed to succeed in their positions. The National Officers also prepared handover reports to ensure their successors are adequately prepared to start their terms at AGM. Incoming National Officers will be attending an introductory session prior to AGM to orient them to the CFMS. I am intending to give them time to brainstorm with GHLs and other global health-interested folks at AGM Global Health Roundtable to help them plan out their terms.

I would be remiss to miss recognition to a specific subgroup of the Global Health Portfolio that has seen much success since its inception. The Health and Environment Adaptive Response Task Force (HEART), led by chair Dr. Finola Hackett, has been doing great work on climate change and health advocacy over the past year. HEART has established a relationship with the Canadian Association of Physicians for the Environment (CAPE), and is currently collaborating regarding the Doctors for Future campaign in support of the Fridays for Future global climate strikes. Their members have launched Twitter, Instagram and Facebook accounts, with a combined following of nearly 300 individuals. Through HEART's leadership, the CFMS has signed on to CAPE's Call to Action on Climate Change and Health. They have developed climate change and health competencies and are advocating for inclusion of these competencies within the medical curriculum. HEART has also strengthened the CFMS relationship with IFMSA-Quebec through our combined advocacy for climate change and health inclusion in the medical curriculum, with the intent of continuing conversations with the AFMC Global Health Network and

starting conversations with CACMS. The work of HEART was presented at the IFMSA August Meeting 2019 by the SCOPH representatives, and was very well-received, with several NMOs asking CFMS delegates how they can advocate for inclusion of climate change in the medical curriculum in their own countries.

2. Serving as CFMS NMO President to the IFMSA

CFMS has made great strides in engaging with the IFMSA throughout my term as CFMS-Canada NMO President. My main responsibilities in this role are to participate with other National Member Organizations (NMOs) on the IFMSA server, and to represent CFMS to the International Federation of Medical Students' Associations (IFMSA). In this role, I led the CFMS delegation to the IFMSA March Meeting in Portorož, Slovenia, where our delegation provided extremely valuable contributions on behalf of the CFMS, including receiving awards for participation in their respective standing committee sessions, presenting CFMS student-led initiatives at the Meeting's Activities Fair, and giving statements on key issues on behalf of the CFMS. Please see the March Meeting 2019 report I have put together for more details on this.

Based upon feedback received from the March Meeting delegation, selection for the August meeting delegation began early, and numerous teleconferences were held in advance of the meeting to ensure participants felts prepared. Unfortunately, I was not able to attend this meeting, however, the Global Health Attaché Fatemeh served as head of delegation to the meeting. Furthermore, selecting the delegation with more time to spare enabled greater participation in the meting. Four of the ten delegates presented CFMS student-led activities to the general assembly, and the presentation on Manitoba's Mife campaign was awarded first place in the activities fair, a great accomplishment. In addition to presenting, myself and several others in the delegation were a part of the policy commissions for the policy papers up for adoption at the meeting. The policy commissions are tasked with ensuring optimal quality of the papers being voted upon at the meeting. CFMS members were part of more policy commissions at this meeting than any other NMO. The delegation again participated extremely well during the meeting and their contributions were greatly appreciated by other NMOs. I have prepared an August Meeting 2019 report where you can review this in more detail.

Beyond the general assemblies, CFMS was privileged to send two board members to the America's Regional Meeting held in Quito, Ecuador in January 2019. That meeting enabled CFMS to build on our engagement with the IFMSA at the regional level, and foster working relationships with other NMOs that may be useful in regional advocacy efforts to organizations such as PAHO. I would be happy to share the report from this meeting with anyone who is interested in accessing it.

While participation in IFMSA general assemblies is limited to a certain number of individuals each year, CFMS has also greatly increased our member engagement with the IFMSA in promoting our members to apply for IFMSA delegations to high-level meetings hosted by organizations such as the UN and the

WHO. A coordinated effort between myself, the Communications Portfolio and the National Officer of Partnerships has led to an uptick in individuals applying for these opportunities to be part of IFMSA delegations (>50 applications throughout my term), and has resulted in six CFMS members being selected to attend high-level meetings as IFMSA delegates and CFMS representatives. The meetings CFMS members have been selected to attend include:

- WHO Executive Board Meeting (January 2019)
- United Nations Commission on the Status of Women (March 2019)
- World Health Assembly (May 2019)
- United Nations Framework Convention on Climate Change Bonn Climate Change Conference (June 2019)
- UNHCR-NGO 2019 Annual Consultations (July 2019)
- 57th Directing Council, 71st Session of the Regional Committee of WHO for the Americas (September 2019)

The Global Health Portfolio Fund has enabled the CFMS to support these individuals as they participate in these opportunities. We have also made use of these opportunities to have CFMS members do takeovers of the CFMS social media accounts and better inform others of the great opportunities available through the IFMSA. In addition to attending meetings as members of IFMSA delegations, CFMS members having been becoming increasingly involved in small working groups and task forces of the IFMSA, further strengthening CFMS-IFMSA relations.

3. Implementing Strategic Plan Goals and Milestones

The main strategic plan goal that I focused on throughout my term is to collaborate with the IFMSA. This is outlined in the previous header. My strategic work over my term has been to envision the next three years of the CFMS global health portfolio. In 2016, the General Assembly approved the 2016-2019 GHP strategic plan. As that time period comes to a close, I reflected upon the milestones we have reached, and where we have fallen short. I was pleasantly surprised to see all that myself and my predecessors in the Director of Global Health role had accomplished over such a short period of time. With that in mind, I felt inspired to continue creating ambitious goals for the Global Health portfolio. Through production of a Strengths/Weaknesses/Opportunities/Threats (SWOT) Analysis, and consultation with National Officers in the Global Health Portfolio (those ending their terms and the incomings), Global Health Liaisons, the Global Health Attaché, and the President-Elect, I have created a Global Health Strategic Plan for 2019-2022. It is my hope that this document will provide guidance for Directors of Global Health to come and will lead the Global Health to further growth and expansion of this massive portfolio. I particularly think this will be useful as the 2019-2020 CFMS board prepare to create portfolio-specific strategic plans.
